# 2024-2025 SCHOLARSHIP APPLICATION For September 1, 2024 to August 31, 2025 Deadline 7/31/2024 11:59 PM EST

The Fencers Club Scholarship Committee will review each application and, following feedback from the Fencers Club DEI and Finance Committees, will provide recommendations regarding scholarship allocations to the Fencers Club Board. The Fencers Club Board will subsequently render the final decision regarding the scholarship allocations.

This duty is consistent with the Club's by-laws Sec 2.04: "To promote the accessibility of the sport of fencing to all individuals regardless of gender, race, age, or socio-economic status."

### **Application Eligibility Criteria**

## **Need-Based Eligibility**

- The applicant has been a Fencers Club member for the past 12 months. This includes PWF
  athletes who have been Fencers Club members for the past 12 months and who have Fencers
  Club listed as their secondary club on the USFA website
  - o Or, has received a letter of recommendation from a Fencers Club coach,
  - o Or, has received letters of recommendation from two existing Fencers Club members
- Has demonstrated financial need (this includes financial hardship due to COVID-19)
- Successful applicants must be able to represent Fencers Club in all competitions, including national tournaments

## "Elite Athlete" Eligibility for Free Fencers Club Membership

- Applicant is an Olympian, Paralympian, or member of the U.S. National team (top 3 for Cadets, top 4 for Juniors, Seniors, Veterans of all age categories) in the last World Championships
- Represented Fencers Club (or PWF, with Fencers Club listed as the secondary club) at the time of the Olympics, Paralympics, or the most recent World Championships

#### **Ineligible to Apply**

Scholarships cannot be granted to NCAA students as this is in violation of the NCAA rules.
 Please apply for the Fencers Club Work-Study Program. Please contact the Executive Director for more information.

#### **Scholarship Awards**

• Over 14 years of age: Successful applicants are eligible to receive a financial award for full or partial remission of membership fees, as well as classes, or private lessons, competition travel

reimbursements, or any combination thereof. Successful applicants may, if they wish, apply for work at club functions. Remuneration will be commensurate with age, experience, and duties.

• 14 years of age and younger: Successful applicants are eligible for awards including full or partial remission of membership fees, as well as classes, or private lessons, competition travel reimbursements, or any combination thereof. Such scholarship awards would entail volunteering at club functions commensurate with age, experience, and skill. Parents or guardians are expected to encourage relevant volunteering. Financial support for anything other than membership dues requires recommendation of the applicant's coach.

# **Application Guidelines**

The application deadline is 7/31/24, 11:59pm EST.

A late or incomplete application will not be considered nor will an application missing the tax forms (see p. 4 of this application for detail). Such applications will be deemed incomplete and will not be considered. There will be no exceptions, except for the "Free Fencers Club Membership" given to the "Elite Athletes."

Though Elite Athletes will automatically qualify for a Free Fencers Club Membership, the Scholarship Committee respectfully asks that Elite Athletes complete the application and submit it before the deadline.

If an Elite Athlete applies for the Free Fencers Club Membership only, there is no need to submit tax forms. However, if an Elite Athlete is requesting to be considered for other awards, in addition to a Free Fencers Club Membership, please submit your tax forms with the application, by the deadline indicated above. Otherwise your award request will not be considered.
